ORDER

In connection with the criminal, anti-national activities of the acting President of the State Cooperative Enterprise Russian Federation - Russia Vladimir Vladimirovich Putin and failure to comply with Legislative Acts GKCHP USSR: Resolution No. SUR 05 dated 03.05.2023, Resolution No. SUR 06 dated 04.05.2023, Resolution No. SUR 08 dated 13.06.2023, Decree No. D/N 005 dated 21.06.2023, Order No. P/07 of 21.06.2023, Decree D/N 006 of 23.06.2023, Resolution No. SUR 09 dated 13.07.2023, World Sovereign Legal Act No. D/N 009 dated 20.07.2023, Decree No. D/N 011 dated 04.08.2023, Decree No. D/N 012 dated 12.10.2023, Decree No. D/N 013 dated 13.10.2023, Decree No. D/N 014 dated 07.11.2023, whose actions led to the restriction of the Rights and Freedoms of Sovereign Citizens of the USSR, a sharp deterioration in the economic situation in the Sovereign Territory of the USSR, the flourishing of corruption and embezzlement, the deterioration of international relations between friendly countries, the open and criminal genocide of the United Sovereign People of the USSR, the destruction of the gene pool of young, able-bodied men, as well as the low standard of living and social injustice, due to the recognition of the uncertainty of physical existence of this subject,



Hereby Orders:

1. To remove from his position the acting President of the State Cooperative Enterprise Russian Federation - Russia Vladimir Vladimirovich Putin without the right to appeal, with all relevant Legal consequences.
2. To assign the responsibility to temporarily fulfill the position of President of the State Cooperative Enterprise Russian Federation - Russia to the Chairman of the State Committee for the State of Emergency of the USSR Boris Khachimovich Satushiev.
3. The State Security Committee of the USSR, the Special Committee of the KGB of the USSR, the Law Enforcement Agencies of the USSR to begin an investigation, with the subsequent issuance of a Legal Assessment of the violation of the Sovereign Legislation of the Great Country of the Sovereign - the Union of Soviet Socialist Republics by USSR Citizen Vladimir Vladimirovich Putin, Acting President of the State Cooperative Enterprise Russian Federation - Russia dated 12.04.2023, as well as the previous period since 2000 in the positions of President and Prime Minister of the Russian Federation - Russia Corporation.

This Order comes into Legal Force from the moment of its signing.
