on ownership of the State Cooperative
Enterprise Russian Federation - Russia.

The final completion of the transaction on the unconditional establishment of ownership of the company „Russian Federation - Russia“ took place on March 8, 2023 and was confirmed by a document - Notification of the People's State Authority on the sovereign Territory of the USSR of the Sovereign International Consumer Cooperative Light Great Russia No. 16 / LET - INF dated 21 February 2023 to all subjects of law.

In accordance with the Sovereign Legislation of the USSR and the completion of registration for the unconditional right of ownership of the company „Russian Federation - Russia“, it was re-registered from the Anglo-British jurisdiction to the Sovereign jurisdiction of the Great Sovereign Country - the Union of Soviet Socialist Republics, namely to the State Register
